

INFORMATION ON PERSONAL DATA PROCESSING

in connection with the organisation of the Baltic Olympiad in Informatics.

In accordance with Article 13 and Article 14 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter referred to as "GDPR"), we inform you that:

Personal Data Administrator:

The controller of personal data collected and processed in connection with the organization of the **Baltic Olympiad in Informatics 2025**, hereinafter referred to as **BOI'2025**, is the Foundation for the Information Technology Development with its registered office in Warsaw, at ul. Topiel 21 lok. 1, entered into the register of associations, other social and professional organizations, foundations and public health care facilities of the National Court Register under the KRS number: 0000025627 by the District Court for the capital city of Warsaw in Warsaw, 12th Commercial Division – Organizer of the Baltic Olympiad in Informatics 2025.
To implement BOI'2025, the Organizer established cooperation with **Nicolaus Copernicus University in Toruń** with its registered office in Toruń (87-100), at ul. Gagarina 11, to whom he entrusted the tasks specified in the agreement regarding the conduct of the BOI'2025 competition and entrusted the processing of personal data on his behalf pursuant to Art. 28 of the GDPR.

Duration of personal data processing:

- Personal data obtained by the Administrator in connection with participation in the BOI'2025 competition are processed for the following period:
- for the duration of BOI'2025, i.e. the period immediately preceding participation in the competition, during the competition and after its completion, and for the period necessary for the Administrator to perform its obligations related to storing (archiving) documentation;
 - until the completion of activities aimed at promoting and disseminating knowledge about BOI'2025 – until the withdrawal of consent or expression of objection to the processing of data for this purpose.

Obligation to provide personal data:

- Providing personal data required in the participation form is a condition for participating in the competition.

Rights of data subjects:

- the person whose personal data is processed has the right to access the content of their personal data and the right to rectify, delete, limit processing, as well as to transfer data and the right to withdraw consent at any time. - everyone has the right to object to the processing of data if their data is processed on the basis of Article 6 paragraph 1 letter f of the GDPR. The appropriate request should be sent to the following e-mail address : iod@fri.edu.pl ;
- in all matters related to the processing of personal data by the Organizer, please contact us at the following e-mail address: iod@fri.edu.pl or by traditional mail to the address of the Administrator's registered office;
- Everyone has the right to lodge a complaint with the President of the Personal Data Protection Office in the event of personal data being processed in breach of the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (GDPR), the Act of 10 May 2018 on the Protection of Personal Data (Journal of Laws of 2018, item 1000) and any other national regulations applying the General Data Protection Regulation [ul. Stawki 2, 02-193 Warsaw].

Sharing personal information:

- Personal data may be disclosed to entities with which personal data processing agreements have been concluded (including accounting services) or to which processing has been entrusted on another legal basis, as well as to other recipients to the extent necessary to organize the BOI'2025 competition. Data may be transferred in connection with the legitimate interest of the Administrator and made available to public entities, at their legitimate request, in accordance with the applicable provisions on the protection of personal data.

Profiling of personal data:

- Personal data will not be processed in an automated manner and will not be profiled.

Source of data acquisition:

- Personal data will be collected during registration for participation in the BOI'2025 competition and during preparations and organization of the competition.
